ORDER

As per the Government Order read as 1st paper above sanction was accorded to M/s BHEL Electrical Machines Ltd., Kasaragod to supply Diesel Generator Sets manufactured and marketed by BHEL Electrical Machines Ltd., Kasaragod directly to all Government Departments and Public Sector Undertakings without following tender formalities for a period of two years from 25-03-2013 in relaxation of rules 57 (a) (ii) of Stores Purchase Manual (Para 9.23 of revised Stores Purchase Manual). Government have extended the period of validity from time to time. The last period of extension granted vide Order read 2nd above, expired on 22.03.2020.

As per the letter read as 3rd paper above the Head Marketing KEL Electrical Machines Ltd., Kasaragod informed that pursuant to the disinvestment of BHEL equity in BHEL-EMI, Government of Kerala has taken over the 51% shares held by BHEL and the company is now a full fledged State Public Sector Undertaking with name change as KEL-Electrical Machines Ltd. and he has requested to re-issue a tender exemption order for 3 years from the date of issue of order, in respect of purchase of Diesel Generator Sets by all Government Departments, Public Sector Undertakings, Local Self Government Bodies etc., directly without following tender formalities.

Government have examined the matter in detail and are pleased to issue orders enabling M/s. KEL Electrical Machines Ltd., Kasaragod (Formerly BHEL) to supply Diesel Generator Sets directly to all Government Departments/ Public Sector Undertakings/ Local Self Government Institutions/ Autonomous Bodies etc without following tender formalities for a period of one year with effect from date of issue of this

order, subject to the following Conditions:-

- a) Application for further extension of validity period should be submitted in advance.
- b) Marketing of the product on the basis of this Order is not allowed after the expiry of the Validity period of this Government Order.
- c) The Purchasing Officer should ensure that the price of the items should not exceed the existing normal market rate of the same.
- d) Steps should be taken on the basis of Circular N.o SPD-A3/12/18-SPD Dated 03.09.2018 for fixing the price of the products.

All Government Departments/ Public Sector Undertakings/ Local Self Government Institutions/ Autonomous Bodies etc.can purchase Diesel Generator sets directly from M/s. KEL Electrical Machines Ltd., Kasaragod as per their requirement without following tender formalities.
