- 6) Installation work shall be covered under warranty against defective material and poor workmanship for a period of 1 year from the date of commissioning.
- 7) Contractor has to visit the site before submitting the offer and necessary clarifications to be obtained if required.
- 8) Contractor shall ensure that workers involved for the said work is covered under ESI scheme and proof for the same shall be submitted prior to commencement of work.
